- The Board moved to approve the 2021-2022 District Calendar. <u>Motion by Director Pierschbacher, second</u> <u>by Director Dickey-Kotz Motion carried unanimously.</u>
- The Board moved to approve the FY22 Budget. <u>Motion by Director Dickey-Kotz second by Director</u> <u>Heltenberg Motion carried unanimously.</u>
- The Board moved to approve the 2-year city of Lamoni contract for rental of the North Park for use of the baseball/softball fields. Contract runs June 1, 2021 to May 31, 2023. <u>Motion by Director Pierschbacher</u>, <u>second by Director Stevenson Motion carried unanimously</u>.

- The Board moved to approve the SWCC Educational contract for Fall 2021 to Spring 2022 for 5 service areas: Health Care, EMT courses, Carpentry/Construction, Welding, and Arts & Sciences courses. <u>Motion</u> by Director Dickey-Kotz, second by Director Pierschbacher Motion carried unanimously.
- The Board moved to approve the cooperative sponsorship of shared athletic programs with Central Decatur in the athletic areas of: Boys Cross Country, Bowling and Wrestling. <u>Motion by Director Heltenberg, second by Director Pierschbacher Motion carried unanimously.</u>

- The Board moved to approve the resignation of Dayton Little as Junior High Baseball coach and approved Chris Cougill for this position for Summer 2021. <u>Motion by Director Dickey-Kotz, second by Director</u> <u>Pierschbacher, Motion carried unanimously.</u>
- The Board moved to approve the non-renewal of a probationary teacher contract for the 21-22 school year. *Motion by Director Dickey-Kotz, second by Director Pierschbacher, Motion carried unanimously.*
- The Board moved to approve the resignation of Larry Heltenberg as a School Board Director as of June 30, 2021. *Motion by Director Dickey-Kotz, second by Director Pierschbacher, Motion carried unanimously.*
- The Board moved to approve the DCLI Construction bid for finish work of the lot south of the greenhouse in the amount of \$5,862.50 and the bid for the finish grade and topsoil to the Chestnut street lot in the amount of \$1,560.00.
