- The Board moved to approve Lawns and More as the provider for snow removal for the District during winter months, if rates stay the same as prior year. <u>Motion by Director Dickey-Kotz, second by Director Stevenson, Motion carried unanimously.</u>

• The Board reviewed the Certified Annual Report (CAR) that was submitted September 15 to the State. These fiscal year end reports included: Transportation, Special Education, Miscellaneous Income, Unspent Authorized Budget (UAB), Balance Sheet, and District Revenues and Incomes. *Motion* by Director Pierschbacher, second by Director Dickey-Kotz to approve the year end reports as presented. *Motion* carried unanimously.

Facility Projects

The School Board reviewed estimated costs for district facility projects including replacing the 25 year old Elementary building chiller, installing a cooling system for the High School gym and an integrated Middle School HVAC system. The Board will establish a work session in November to meet with Matt Gillaspie, Piper Sandler, and review utilization of ESSER III, SAVE and PPEL as potential funding sources and structures.
